(b) On April 19, 2007, Lithium Technology Corporation (the Company) was informed of the death of Mr. Harry van Anandel, the Chairman of the Board of the Company who passed away on April 18, 2007. Mr. van Anandel has served as the Company's Chairman since January 2005 and as a director of the Company since November 2002. Mr. van Anandel also served as the Chief Executive and Executive Director of the Company's subsidiary GAIA Holding B.V. and was a member of the Supervisory Board of Directors of GAIA GmbH. Mr. van Anandel served as the Chief Executive of Arch Hill Capital NV since 1988 and held directorships in a number of Dutch and British private companies in which Arch Hill Capital has invested.
