Hercules Announces Offering of Common Stock

Palo Alto, Calif. May. 29, 2007 Hercules Technology Growth Capital, Inc. (NASDAQ: HTGC), a leading specialty finance company providing debt and equity growth capital to venture capital and private equity backed technology and life science companies, announced today that it plans a public offering of approximately 8,000,000 shares of its common stock. In connection with the offering, Hercules intends to grant the underwriters an option to purchase up to an additional 1,200,000 shares to cover over-allotments, if any.

The net proceeds to Hercules Technology Growth Capital, Inc. from the sale of the shares in the offering are intended to repay indebtedness and for general corporate purposes.

Credit Suisse Securities (USA) LLC will act as Sole Book-Running Manager, JMP Securities LLC as Joint Lead Manager and A.G. Edwards & Sons, Inc., Piper Jaffray & Co., and Ferris, Baker Watts, Incorporated as Co-Managers of the offering.
