Explanatory Note

As previously disclosed, on March 1, 2009, Spansion Inc. (the *Company*), Spansion Technology LLC, Spansion LLC, Cerium Laboratories LLC and Spansion International, Inc. (collectively, the *Debtors*) filed voluntary petitions in the United States Bankruptcy Court for the District of Delaware (the *Bankruptcy Court*) seeking relief under the provisions of Chapter 11 of Title 11 of the United States Code (the *Bankruptcy Code*). The Debtors continued to operate their businesses as debtors-in-possession under the jurisdiction of the Bankruptcy Court and in accordance with the applicable provisions of the Bankruptcy Code and the orders of the Bankruptcy Court.

On April 16, 2010, the Bankruptcy Court entered an order (the *Confirmation Order*) confirming and approving the Debtors' Second Amended Joint Plan of Reorganization Dated April 7, 2010 (As Amended) (including all exhibits thereto, and as modified by the Confirmation Order, the *Plan*). A summary of the material features of the Plan, including the related rights offering and financing arrangements, is contained in the Company's Current Report on Form 8-K filed with the Securities and Exchange Commission on April 22, 2010.

On May 10, 2010 (the *Effective Date*), the Plan became effective. The events described below occurred as a result of the consummation of the Plan.

Item 3.02. Unregistered Sales of Equity Securities.

On the Effective Date, the Company reserved for issuance 46,247,760 unregistered shares of the Company's Class A Common Stock, par value \$0.001 per share (the *Class A Common Stock*), to satisfy the allowed claims of certain unsecured creditors, as specified in the Plan, except for (i) certain classes of unsecured creditors as specified in the Plan, (ii) holders of claims up to \$2,000, who will receive cash for their claims, and (iii) distributions to the holders of the exchangeable debentures of Spansion LLC, whose distributions are instead to be made to the holders of the senior notes of Spansion LLC in accordance with the subordination provisions of the exchangeable debentures.

As previously disclosed, the Company issued and distributed an aggregate of (i) 11,936,410, (ii) 1,023,187, (iii) 10,976, (iv) 145,222 and (v) 3,367,408 unregistered shares of Class A Common Stock on May 26, 2010, July 7, 2010, September 7, 2010, November 17, 2010 and November 18, 2010, respectively, to holders of certain allowed unsecured claims and the holders of the senior notes of Spansion LLC (collectively, the *Prior Distributions*).

On December 8, 2010, the Company issued and distributed an aggregate of 15,176,979 unregistered shares of Class A Common Stock to holders of certain allowed unsecured claims and the holders of the senior notes of Spansion LLC as part of the sixth distribution to such holders as provided in the Plan (the *Sixth Distribution* and together with the Prior Distributions, the *Distributions*). The Sixth Distribution consisted of 5,158,976 shares distributed to U.S. Bank National Association AS, as trustee of the senior notes of Spansion LLC, and 4,702,853 shares distributed to holders of certain other allowed unsecured claims. The Sixth Distribution also included the issuance of 5,315,150 shares to Spansion LLC in connection with Spansion LLC's acquisition of a portion of Spansion Japan's claim, and these shares will be retired.

Supplemental distributions of the remaining 14,587,578 unregistered shares reserved for issuance will take place on at least a quarterly basis, provided, with certain exceptions, that the Company has at least 100,000 shares of Class A Common Stock available for distribution.

The shares of Class A Common Stock issued as part of the Distributions are and, when issued, the remaining 14,587,578 shares of Class A Common Stock reserved for issuance to satisfy the allowed claims of certain unsecured creditors in accordance with the Plan will be, and exempt from registration requirements of the Securities Act of 1933, as amended, in reliance on Section 1145 of the Bankruptcy Code.
