### Item 7.01 Regulation FD Disclosure

Officers of WellPoint, Inc. ( WellPoint ) expect to speak with securities analysts and investors during the period commencing on September 9, 2014, and ending on September 30, 2014. During these meetings, the officers expect to reaffirm WellPoint's net income guidance for full year 2014 of greater than \$8.61 per share, including net favorable items of \$0.21 per share from the first two quarters of 2014 and an after-tax charge not to exceed \$0.20 per share related to debt refinancing initiated in August of 2014. Excluding these items and charge, the Company continues to expect adjusted net income to be greater than \$8.60 per share. This guidance includes no investment gains or losses beyond those recorded during the first six months of 2014.

None of the information furnished in Item 7.01 hereto shall be deemed to be filed for purposes of Section 18 of the Securities Exchange Act of 1934, as amended. Unless expressly set forth by specific reference in such filings, none of the information furnished in this report shall be incorporated by reference in any filing under the Securities Act of 1933, as amended, whether made before or after the date hereof and regardless of any general incorporation language in such filings.
