Item 1. Security and Issuer

This statement amends the Schedule 13D dated February 10, 2009 (the **Schedule 13D**), as modified by amendments filed February 10, 2009, March 19, 2009, May 12, 2009, May 19, 2009, January 12, 2011, March 30, 2011, June 7, 2011, September 16, 2011, June 8, 2012, September 9, 2013 and September 2, 2014 (the **Amended Schedule 13D**) filed on behalf of the Reporting Person, with respect to the common stock, \$.001 par value per share (**Common Shares**), of Collectors Universe, Inc., a Delaware corporation (the **Company**).

Item 5. Interest in Securities of the Issuer

- (a) The Reporting Person beneficially owns 413,543 Common Shares, which represents approximately 4.66% of the outstanding Common Shares. The percentage of beneficial ownership of the Reporting Person, as reported in this Schedule 13D/A, was calculated based on 8,878,476 Common Shares outstanding as of April 30, 2015, as reported by the Issuer in its Quarterly Report on Form 10-Q filed with the U.S. Securities and Exchange Commission on May 6, 2015.
- (b) The Reporting Person has the sole power to vote and dispose of 413,543 Common Shares.
- (c) The transactions in the Issuer s Common Shares by the Reporting Person since his previously filed Schedule 13D/A are listed on Exhibit 1 attached hereto and made a part hereof. All such transactions were effected in the open market on the NASDAQ Global Market.
