On August 13, 2015, Farmers National Banc Corp. (the Company) first utilized an investor presentation reflecting the Company's financial results for the quarter ended June 30, 2015. The investor presentation also reviewed the Company's previously announced proposed merger with Tri-State Banc, Inc. (Tri-State), the parent company of National Community Bank (FNCB), pursuant to the Agreement and Plan of Merger (the Merger Agreement) among the Company, Tri-State, and FMNB Merger Subsidiary, LLC, a newly-formed wholly-owned subsidiary of the Company (the Merger).

A copy of the investor presentation is attached hereto as Exhibit 99.1 and incorporated herein by reference. The investor presentation is furnished herein, as part of this Item 7.01, as Exhibit 99.1. Pursuant to General Instruction B.2 of Current Report on Form 8-K, the information in this Item 7.01 and Exhibit 99.1 shall not be deemed to be filed for purposes of Section 18 of the Securities Exchange Act of 1934, as amended (the Exchange Act), or otherwise subject to the liability of that section. Furthermore, the information in this Item 7.01 and Exhibit 99.1 shall not be deemed to be incorporated by reference into the filings of the Company under the Securities Act of 1933, as amended (the Securities Act), or the Exchange Act, except as may be expressly set forth by specific reference in such filing.

The respective directors and executive officers of the Company and Tri-State and other persons may be deemed to be participants in the solicitation of proxies from shareholders of Tri-State with respect to the proposed Merger.
