#### **DEREGISTRATION OF SECURITIES**

This Post-Effective Amendment (this <u>Post-Effective Amendment</u>) relates to (A) the Registration Statement of Avago Technologies Limited. (the <u>Company</u>) on Form S-3 (File No. 333-168621) filed with the Securities and Exchange Commission (the <u>SE</u>C) on August 6, 2010, (B) the Registration Statement of the Company on Form S-3 (File No. 333-191991) filed with the SEC on October 30, 2010 and (C) the Registration Statement of the Company (File No. 333-198287) filed with the SEC on August 21, 2014 (each of the foregoing Registration Statements are referred to herein as a <u>Registration Statement</u> and, together, as the <u>Registration Statements</u>).

On February 1, 2016, pursuant to the terms of the Agreement and Plan of Merger (as amended, the <u>Merger Agreement</u>), dated as of May 28, 2015, by and among the Registrant, Pavonia Limited, Broadcom, Safari Cayman L.P., Avago Technologies Cayman Holdings Ltd., Avago Technologies Cayman Finance Limited, Buffalo CS Merger Sub, Inc. (<u>CS Merger Sub</u>) and Buffalo UT Merger Sub, Inc. (<u>UT Merger Sub</u>, and, together with CS Merger Sub, the <u>Merger Subs</u>), (a) the Registrant was acquired (indirectly) by Pavonia Limited pursuant to the terms of a scheme of arrangement under Singapore law consummated in accordance with Section 210 of the Companies Act (Chapter 50 of Singapore), and (b) the Merger Subs merged with and into Broadcom, with Broadcom as the surviving corporation in such mergers (collectively, the <u>Transactions</u>). As a result of the Transactions, both the Registrant and Broadcom became indirect subsidiaries of Pavonia Limited.

As a result of the Transactions, the Registrant has terminated any offerings of securities pursuant to the Registration Statements. In accordance with the undertakings made by the Registrant in the Registration Statements to remove from registration by means of a post-effective amendment any of the securities that had been registered which remain unsold at the termination of the offering, the Registrant hereby removes from registration any securities of the Registrant registered but unsold under the Registration Statements as of the date hereof.
