(1) An option to purchase 45,000 shares of common stock at an exercise price of \$28.35 was granted on March 21, 2007. Fifty percent of the option shall vest two years and three months from March 21, 2007 which is June 21, 2009 and the remaining fifty percent shall vest two years and six months from March 21, 2007 which is September 21, 2009, such that the option shall be fully vested on the two year and six month anniversary of the grant date which is September 21, 2009.

(2) The shares are held by the Shannon Revocable Trust (the "Trust"), dated 9/24/97, of which the Reporting Person is a trustee.

(3) Includes 632 shares acquired under NVIDIA's 1998 Employee Stock Purchase Plan (Section 423 Plan) on February 28, 2007.
