(1) The transaction is disclosing a dividend that is exempt from reporting under Rule 16a.

On December 4, 2013, the issuer declared a dividend, payable to all holders of record of common stock on December 16, 2013 (the "Dividend"). In accordance with the terms of the January 2, 2013 and October 14, 2013 Restricted Stock Agreements, 82 additional shares of restricted stock were received by the reporting person in connection with the Dividend. The additional shares of restricted stock

(2) will vest as follows: (i) 54 shares will vest at a rate of 20% annually beginning on January 2, 2014; (ii) 14 shares will vest at a rate of 20% annually beginning on October 14, 2019; and (iii) 14 shares will vest at a rate of 20% annually beginning on October 14, 2019, but shall immediately vest if the market price of the issuer's common stock exceeds \$35.00 per share for a period of 10 trading days, which need not be consecutive.

(3) Represents 16,624 shares of restricted stock.

(4) Shares were withheld by the issuer solely to cover the minimum income tax withholding requirements associated with the vesting of 2,205 shares of restricted stock.

(5) Represents 14,419 shares of restricted stock.
