Novo Nordisk A/S – Share repurchase programme

Bagsværd, Denmark, 2 September 2013 – On 8 August 2013, Novo Nordisk initiated a share repurchase programme in accordance with the provisions of the European Commission’s regulation no 2273/2003 of 22 December 2003, also referred to as the Safe Harbour rules. This programme is part of the overall share repurchase programme of up to DKK 14.0 billion to be executed during a 12-month period beginning 31 January 2013.

Under the programme initiated 8 August 2013, Novo Nordisk will repurchase B shares for an amount up to DKK 2.5 billion in the period from 8 August 2013 to 29 October 2013.

Since the announcement as of 26 August 2013, the following transactions have been made under the programme:
