- (1) Each share of class B common stock, par value \$0.01, of the issuer (the "Class B Common Stock") is convertible at any time, at the option of the holder, into one share of class A common stock, par value \$0.01, of the issuer (the "Class A Common Stock").

- (3) On July 18, 2005, and August 1, 2005, the reporting person was granted an aggregate of 180,000 shares of restricted Class B Common Stock. The restricted Class B Common Stock vests upon certain liquidity events if certain performance criteria are met. Upon the occurrence of the Issuer's recent secondary public offering, which was consummated on May 25, 2007, 46,703 shares of restricted Class B Common Stock vested.
