The Reporting Person has the right, exercisable from time to time, to exchange each Fortress Operating Group Unit for one Class A share of the Company; provided, that one Class B share of the Company (which has no economic interest in the Company) is concurrently delivered to the Company for cancellation. The Reporting Person owns Class B shares in the same amount as the Reporting Person's Fortress Operating Group Units. Such shares represent no economic interest in the Company and are not separately reported herein. The Fortress Operating Group Units have no expiration date.
 - (3) This includes 14,000,000 Fortress Operating Group Units previously held by The Randal A. Nardone 2007 Annuity Trust, 300,000 Fortress Operating Group Units previously held by The Nardone Family 2007 Annuity Trust #1, and 300,000 Fortress Operating Group Units previously held by The Nardone Family 2007 Annuity Trust #2.
