 - (1) Performance Unit Grant of a maximum of 3,533 units (150% of the base number of Units granted) under the 2008 Performance Plan, contingently payable (to the extent earned) 100% in shares of Common Stock, in February, 2013. The grantee may elect to defer (in Common Stock equivalents) all or a portion of the grant earned. Amounts deferred will be paid in shares of Common Stock. The number of Units paid, which can be zero to 3,533 Units, depends 50% on the attainment of a net income target and 50% on the attainment of a cash flow target over a 1-year period ending December 31, 2010.
 - (2) Non-Qualified Stock Option in respect of shares of common stock granted under the 2008 Performance Plan.
 - (3) The option vests and becomes exercisable in 25% increments over four years commencing one year after the date of grant.
 - (4) Restricted Stock Units, each equivalent to a share of common stock, granted under the 2008 Performance Plan.
 - (5) The Restricted Stock Units vest and convert into shares of common stock in 33% increments each year commencing three years after the date of grant.
