  - (1) The shares were issued in accordance with a consulting agreement between the Reporting Person, Colonial Ventures LLC and the Issuer and shall vest in accordance with the following schedule: 50% upon execution of the agreement and 50% on the one year anniversary of the agreement.
  - (2) Represents 2,750,000 shares of Common Stock issued to Colonial Ventures, LLC and 750,000 shares of Common Stock issued to Michele Cohen, Reporting Person's wife. Reporting Person has sole voting and dispositive power over the shares held by Colonial Ventures, LLC. Colonial Ventures, LLC has designated certain third-parties as recipients of 1,500,000 shares of Common Stock, as to which Reporting Person disclaims beneficial ownership.
