The lowest total purchase price of the shares, including commissions, was therefore \$5.52 per share, which is the same as the sales price of the 281,673 shares reported as sold in this Form 4. Such sale was a private sale to a member of the Reporting Person's family, and there were no commissions associated with that sale.
