- (1) Restricted shares granted pursuant to the Invacare Corporation 2003 Performance Plan in an exempt transaction under Rule 16b-3. These shares vest in 25% increments over four years commencing November 15, 2011.

All options were granted between November 14, 2000 and December 11, 2009, at an exercise price between \$10.695 and \$47.01 per share, will expire between November 14, 2010 and August 20, 2018 and became or will become exercisable between December 31, 2001 and January 1, 2013.
