(1) Niska Sponsor Holdings Cooperatief U.A. ("Sponsor Holdings") directly owns 49.2% of the common units, 100% of the subordinated units and 100% of the incentive distribution rights in Niska Gas Storage Partners LLC (the "Company"). It also indirectly owns, through Niska Gas Storage Management LLC, a 1.98% managing member interest in the Company. All of the reporting persons' ownership is indirect through Sponsor Holdings.

(2) Following an internal reorganization, the reporting persons, by reason of the relationships described below, may be deemed to be the beneficial owners of the shares reported herein beneficially owned by Carlyle/Riverstone Energy Partners III, L.P. and C/R Energy GP III, LLC (the "Carlyle Funds"). Each of the reporting persons expressly disclaims beneficial ownership of any such securities, except to the extent of its pecuniary interest therein.

(3) The indirect parent of the Carlyle Funds is now TC Group Sub, L.P. The general partner of TC Group Sub, L.P. is TC Group, L.L.C. The managing member of TC Group, L.L.C. is Carlyle Holdings I L.P. The general partner of Carlyle Holdings I L.P. is Carlyle Holdings I GP Sub L.L.C. The managing member of Carlyle Holdings I GP Sub L.L.C. is Carlyle Holdings I GP Inc. The sole shareholder of Carlyle Holdings I GP Inc. is The Carlyle Group L.P. The general partner of The Carlyle Group L.P. is Carlyle Group Management L.L.C., which is managed by an eight person board of directors, with all board action relating to the voting or disposition of these shares requiring approval of a majority of the board. All members of the board of directors expressly disclaim beneficial ownership of the shares reported herein.

(4) The subordinated units will convert into common units on a one-for-one basis at the end of the subordination period described in the Issuer's Registration Statement on Form S-1 (File No. 333-165007)
