(1) Shares of the Company's Class A Common Stock received from the vesting of 1/12 of the restricted stock unit award granted on November 28, 2011.

The stock units will be fully vested on November 28, 2014.

(7) Excludes previously granted restricted stock units for an aggregate of 89,377 shares of Class A Common Stock, which have different vesting schedules.

(8) The performance-based restricted stock units were granted on November 28, 2011 under the Cognizant Technology Solutions Corporation 2009 Incentive Compensation Plan. In accordance with the performance-based restricted stock unit award, 1/3 of the vested performance-based restricted stock units were issuable on the eighteen-month anniversary of the date of grant of such performance-based restricted stock units, provided the reporting person remained in the Company's service through such anniversary date. The remaining 2/3 of the vested performance-based restricted stock units shall be issued on the thirty-six month anniversary of the date of grant of such performance-based restricted stock units, provided that the reporting person remains in the Company's service through such anniversary date.

(9) Excludes previously granted restricted stock units for an aggregate of 84,967 shares of Class A Common Stock, which have different vesting schedules.
