(1) The sales reported in this Form 4 were effected pursuant to a pre-arranged trading plan established in accordance with Rule 10b5-1 of the Securities Act of 1934, as amended.

(2) The price range for the aggregate amount sold by the direct holder is \$258.19 - \$259.02.
