- (1) On May 18, 2017, the reporting person was granted 2,380 shares of restricted stock, subject to the achievement by the Company of performance vesting criteria based on the Company's average return on equity measured at the end of fiscal 2018. On May 7, 2018 the performance vesting criteria was determined to have been met such that 2,290 shares of restricted stock became earned and reportable on such date.
