**Brasil Telecom Clarifies CVM's Inquiries**

In compliance with the Brazilian Securities and Exchange Commission's (Comissão de Valores Mobiliários - CVM) letter CVM/SEP/GEA-2/No. 310/07, submitted on August 23<sup>rd</sup>, 2007, regarding news published on this date by the Valor Econômico newspaper (page B-3), under the title *Governo exige sócio nacional na BrT-Oi*, Brasil Telecom Participações S.A. and Brasil Telecom S.A. (together, the Company) clarify that they are not participating in any negotiations on the part of their controlling shareholders involving the transfer of shares of companies within their corporate shareholder group. Furthermore, the Company restates that they have not established any understanding, even preliminarily, about merger, acquisition or sale regarding Telemar or any companies related to it.

The Company also advises that their controlling shareholders (Solpart Participações S.A., Techold Participações S.A., Invitel S.A. and Zain Participações S.A.) have nothing to add regarding the issue clarified above.
