Press Release Regarding Commencement of Exploratory Drilling at Gold Hills (Serra do Ouro)

On August 16, 2012, Ardent Mines Limited (the “Company”) announced that it has contracted Drilrent Ltd., a Brazilian-based company, to commence an exploratory drilling campaign at Gold Hills (Serra do Ouro), the Company’s flagship property located in Northeast Brazil. Press Release Regarding Permit to Commence Exploration Program at Misty Hills (Serra do Sereno) Project in Carajás, Brazil
