Millennium Management LLC, a Delaware limited liability company ("Millennium Management"), is the general partner of the managing member of Integrated Core Strategies, and may be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies.

Israel A. Englander, a United States citizen ("Mr. Englander"), is the managing member of Millennium Management and may also be deemed to have shared voting control and investment discretion over securities owned by Integrated Core Strategies.

The foregoing should not be construed in and of itself as an admission by Millennium Management or Mr. Englander as to beneficial ownership of the securities owned by Integrated Core Strategies.

(b) Percent of Class:

As of the close of business on January 9, 2015, Millennium Management and Mr. Englander may be deemed to have beneficially owned 748,770 shares or 3.8% of the Issuer's Common Stock outstanding (see Item 4(a) above), which percentage was calculated based on 19,580,769 shares of Common Stock outstanding as of November 1, 2014, as per the Issuer's Form 10-Q dated November 7, 2014.
