1. To elect three (3) directors to the Board of Directors of the Company for a three year term expiring in 2018;
2. To approve, on an advisory basis, a non-binding resolution regarding the compensation of our named executive officers;
3. To ratify the appointment of Baker Tilly Virchow Krause, LLP as the Company’s independent registered public accounting firm for the fiscal year ending December 31, 2015.

The shareholders elected the directors to the term stated above, approved the non-binding resolution regarding the compensation of our named executive officers and ratified the appointment of Baker Tilly Virchow Krause, LLP as the Company’s independent registered public accounting firm for the fiscal year ending December 31, 2015.
