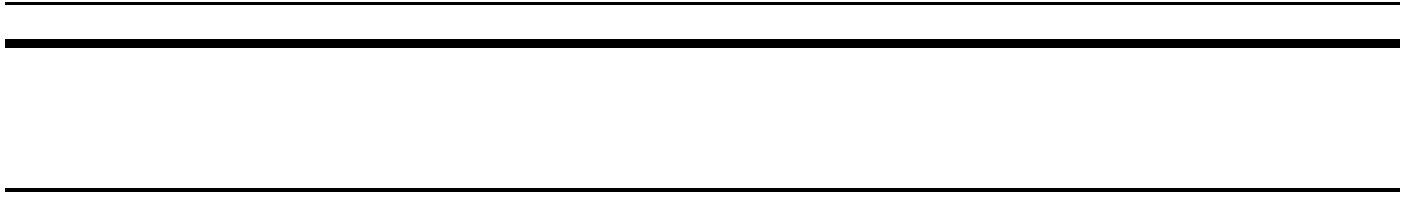

On July 1, 2013, David Krietzberg, Chief Administrative Officer (“CAO”) informed Crexendo, Inc. (“the Company”) that he is resigning as CAO effective July 15, 2013.
