- The Reporting Person was granted a restricted stock option of 8,000 shares on August 28, 2008. One-third of the shares vest on the first, second and third anniversaries of the date of grant. Therefore 2,667 shares vested on August 28, 2009. The Reporting Person is required (1) to pay withholding obligation associated with the vesting of the shares, the Issuer's Board of Directors expressly authorized share withholding for the payment of this obligation, and the Reporting Person has elected share withholding for the payment of this obligation. Therefore, the Issuer withheld for tax obligations 873 shares of the 2,667 shares otherwise issuable.
- This Form 4 reports (i) the disposition of these 873 shares by the Reporting Person to the Issuer to pay the tax liability associated with the (2) vesting and (ii) the net increase in the Reporting Person's ownership of 1,794 shares. The price of \$3.37 is equal to fair market value on the date of vesting and is used to determine both the value of the shares that vest and the value of the shares withheld.
