#### Item 1. Security and Issuer

This Amendment No. 5 ("Amendment No. 5") amends and supplements the statements on Schedule 13D filed with the Securities and Exchange Commission on September 16, 1992 (the "Original Schedule 13D"), as amended on October 17, 2002, October 22, 2002, October 30, 2002, and January 8, 2015 (collectively with the Original Schedule 13D and this Amendment No. 5, the "Schedule 13D") with respect to the common stock, par value \$0.05 per share (the "Common Stock"), of Scientific Industries, Inc., a Delaware corporation (the "Issuer"). This Amendment No. 5 reflects a change in beneficial ownership of the Reporting Person by 1% or more, and also serves to correct a clerical error in Amendment No. 4, filed on January 8, 2015, relating to the number of shares beneficially owned by the Reporting Person with sole voting and dispositive power. Specifically, Amendment No. 4 inaccurately reported the number of shares beneficially owned by the Reporting Person with sole voting and dispositive power as 110,600; the correct number of shares beneficially owned by the Reporting Person with sole voting and dispositive power was 110,690. The Statement is hereby amended to correct such inaccuracy.

Capitalized terms used herein and not otherwise defined in this Amendment No. 5 have the meanings set forth in the Original Schedule 13D. Only those items that are reported herein are amended, and only to the extent amended herein; all other items, including previously filed exhibits, remain unchanged and are incorporated by reference herein.

#### Item 2. Identity and Background

- (a) This Schedule 13D is filed by Lowell A. Kleiman (the "Reporting Person").

#### **Item 4. Purpose of Transaction**

Since the filing of the Original Schedule 13D, the Reporting Person has sold 49,581 shares of Common Stock in the ordinary course of his investment activities and not with any purpose of, or with the effect of, changing or influencing the control of the Issuer, or in connection with or as a participant in any transaction having that purpose or effect. All of the information set forth in the responses Item 4 of the Original Schedule 13D otherwise remains in full force and effect and is incorporated by reference herein.

#### Item 5. Interest in Securities of the Issuer

- (a) The Reporting Person owns beneficially in the aggregate 90,000 shares of Common Stock, constituting 6.04% of the shares outstanding based on 1,489,112 shares of Common Stock outstanding as of October 30, 2015.
- (b) The Reporting Person has sole power to vote and to dispose of the 60,000 shares of Common Stock owned by him.
- (c) The Reporting Person has shared power to vote and to dispose of the 30,000 shares of Common Stock owned by him and his wife, Priscilla H. Kleiman, as joint tenants with the right of survivorship.
