Capitol Federal Financial, Inc. (the “Company”) held its Annual Meeting of Stockholders on January 27, 2015 (the “Annual Meeting”). Holders of record of the Company’s common stock at the close of business on December 5, 2014 were entitled to vote on three items at the Annual Meeting. Stockholders elected Morris J. Huey, II and Reginald L. Robinson each to a three-year term as director. The stockholders approved, on an advisory basis, the compensation of the Company’s named executive officers, as disclosed in the Company’s proxy statement for the Annual Meeting. The stockholders also ratified the appointment of Deloitte & Touche, LLP as the Company’s independent auditors for the fiscal year ending September 30, 2015.
