- (1) Restricted stock units convert into common stock on a one-for-one basis.
- (2) On December 15, 2017, the reporting person had 522 shares withheld and cancelled to cover minimum required tax withholdings due to the vesting of restricted stock units. These share cancellations are shown on Table I as dispositions (Transaction Code "D" in Column 4),

although none of these cancelled shares were sold into the market, as indicated by Transaction Code "F" in Column 3.

- (3) On December 17, 2017, the reporting person had 422 shares withheld and cancelled to cover minimum required tax withholdings due to the vesting of restricted stock units. These share cancellations are shown on Table I as dispositions (Transaction Code "D" in Column 4), although none of these cancelled shares were sold into the market, as indicated by Transaction Code "F" in Column 3.

- (4) The NFG stock fund under the NFG 401(k) plan is denominated in units, representing ownership interests in a fund that includes both NFG common stock and a reserve of cash. The information reported represents the dollar value of the reporting person's balance in the NFG stock fund as of December 15, 2017, as reported by the plan administrator, divided by the closing price of NFG common stock on that date.

- (5) On December 15, 2016, the reporting person was granted 4,233 restricted stock units, vesting as follows: 1,411 on December 15, 2017, 1,411 on December 15, 2018, and 1,411 on December 15, 2019.

- (6) On December 17, 2015, the reporting person was granted 3,424 restricted stock units, vesting as follows: 1,141 on December 17, 2016, 1,141 on December 17, 2017, and 1,142 on December 17, 2018.
