The Shares were acquired for a purchase price of \$100,099.561654 per share (representing \$100,000 per share liquidation preference and accrued dividends of \$99.561654 per share). PFC is a wholly owned subsidiary of Bank of America Corporation ("Bank of America").
- (2) This statement is jointly filed by Bank of America and PFC. Bank of America holds an indirect interest in the securities listed in Table I (the "Securities") by virtue of its indirect ownership of its subsidiary PFC.
