- (1) The Reporting Person was awarded a grant of 29,116 restricted stock units (RSUs). The RSUs vest in full on the five year anniversary of the grant date (i.e., October 21, 2018), provided the Reporting Person is still an employee of the Issuer on that date. Each RSU represents the contingent right to receive one share of RGS common stock upon vesting.
 - (2) The Reporting Person was awarded a grant of 3,346 restricted stock units which vest ratably over a three year period. Each RSU represents the contingent right to receive one share of RGS common stock upon vesting.
 - (3) Stock Appreciation Rights vest ratably over a three year period.
