The shares to which this form relates are registered in the name of Deutsche Bank AG, as nominee for T-Mobile Holdings Limited. The Deutsche Telekom group of companies undertook an intragroup reorganisation on 23 March 2018 which involved three key steps:

- (i) the transfer of 100% of the shares in T-Mobile Holdings Limited to CTA Holding GmbH. At that time, CTA Holding GmbH was owned 100% by Deutsche Telekom AG;
- (ii) the sale by Deutsche Telekom AG of 7% of the shares in CTA Holding GmbH to Telekom Deutschland GmbH ("TDG") and 17% of the shares in CTA Holding GmbH to T-Systems International GmbH ("TSI") (TDG, TSI and Deutsche Telekom AG, together, the "CTA Sellers"); and
