On December 9, 2013, the United States District Court for the District of New Jersey (the "Court"), in the action captioned Justin Holland v. New Jersey Resources Corporation, et al., Case No.: 3-12-cv-07858-PGS-LHG, issued an order (the "Order") preliminarily approving a proposed settlement (the "Settlement") by and among the named plaintiff in the above-captioned action, on behalf of himself and derivatively on behalf of New Jersey Resources Corporation, and the named defendants in the above-captioned action, on the terms and conditions set forth in the Stipulation and Agreement of Settlement, executed on November 25, 2013, and filed with the Court on November 26, 2013 (the "Stipulation"). The Order preliminarily approved the Settlement, subject to the Court's final approval, and approved as to form, content, and manner of distribution the Notice to New Jersey Resources Shareholders attached as Exhibit B to the Stipulation, and attached hereto in substantially similar form as Exhibit 99.1.
