With respect to these shares, the reporting person does not have the right to vote, receive, or be entitled to receive, cash or non-cash dividends or any other beneficial rights as a shareholder of the Company.
  - (2) 0.795 shares have accrued to the reporting person's account under the KCS Employee Stock Ownership Plan.
  - (3) Limited Stock Appreciation Rights ("LSARs") are granted in tandem with stock options.
