The amount assumes the exchange of all outstanding shares of Series B Cumulative Convertible Preferred Stock for shares of Common Stock of Hecla Mining Company. If all Preferred Stock is exchanged, Hecla would issue an aggregate of 16,100,000 shares of its Common Stock. Based on the June 17, 2002 average of the reported high and low price of Hecla Series B Cumulative Convertible Preferred Stock on the New York Stock Exchange, the transaction value is \$61,640,000. The amount of the filing fee, calculated in accordance with Rule 0-11 of the Securities Exchange Act of 1934, as amended, equals 1/50th of one percent of the transaction value.

This Amendment No. 4 further amends and supplements the Tender Offer Statement on Schedule TO filed with the Securities and Exchange Commission on June 24, 2002 as previously amended (the "Schedule TO") by Hecla Mining Company, a Delaware corporation, in connection with its offer of 7 shares of common stock, par value \$0.25 per share, of Hecla in exchange for each of Hecla's 2,300,000 currently outstanding shares of Series B Cumulative Convertible Preferred Stock, par value \$0.25 per share upon the terms and subject to the conditions set forth in the Offering Circular, dated June 24, 2002 and in the related Letter of Transmittal, which together, as each may be amended or supplemented from time to time, constitute the "Offer" and which are appended to and filed with the Schedule TO as Exhibits (a)(1) and (a)(2), respectively.

Hecla Mining Company announced the final results of its offer to holders of its Series B Cumulative Convertible Preferred stock to exchange each of their preferred shares for 7 shares of Hecla common stock. The offer expired at 5:00 p.m., New York City time, on July 25, 2002.

Based on a final count by American Stock Transfer & Trust Company, the Exchange Agent for the offer, 1,546,598 shares were properly tendered and not withdrawn, of which 24,405 were tendered pursuant to notices of guaranteed delivery. Hecla will accept all of the properly tendered shares. Delivery of shares of Hecla common stock in exchange for accepted shares will be promptly made by American Stock Transfer & Trust Company.

Hecla commenced the offer on June 24, 2002, at which time there were 2.3 million shares of Series B Cumulative Convertible Preferred stock issued and outstanding. As a result of the completion of the exchange offer, Hecla has 753,402 shares of Series B Cumulative Convertible Preferred stock issued and outstanding as of the time immediately following issuance of the exchanged shares. As a result of the exchange, the outstanding shares of common stock increased from 75,151,603 million to 85,977,789 million.
