#### ITEM 8.01 OTHER EVENTS.

On January 25, 2006, Cytogen Corporation (the "Company") announced that it has filed a complaint against Advanced Magnetics, Inc. in the Massachusetts Superior Court for breach of contract, fraud, unjust enrichment, and breach of the implied covenant of good faith and fair dealing in connection with the parties' 2000 license agreement, as amended, for both Combidex(R) and ferumoxytol, formerly Code 7228.

These matters were announced in a press release issued January 25, 2006, which is attached hereto as Exhibit 99.1. The Complaint with respect to these matters is attached hereto as Exhibit 99.2.

The Company does not intend to file further current reports on Form 8-K describing pleadings with related to this lawsuit, unless material to the Company.
