- (1) On April 23, 2007, Dr. Harman and his wife entered into an agreement to partition into separate property 818,892 shares that were held as community property in a revocable trust for which Dr. Harman served as trustee. As a result, Dr. Harman and his wife each own 409,446 of these shares as separate property. Dr. Harman transferred ownership of his 409,446 shares along with an additional 1,105,414 shares held in a trust to a new trust for which he serves as sole trustee. Dr. Harman's wife transferred ownership of her 409,446 shares to a trust for which she serves as sole trustee. Dr. Harman disclaims beneficial ownership of the 409,446 shares owned by his wife. In addition, 171,164 shares are held in the Sidney Harman Charitable Remainder Trust for which Dr. Harman has sole dispositive power and sole voting power and 154,416 shares are held in an irrevocable trust for various family members for which Dr. Harman has sole voting power but shared dispositive power.
