Section 5 – Corporate Governance and Management

Item 5.07 Submission of Matters to a Vote of Security Holders.

(a) Summit Financial Group, Inc. (the “Company”) held its Annual Meeting of Shareholders on May 15, 2014 in Moorefield, West Virginia for the purpose of considering and voting upon the following:

i. To elect five (5) directors to serve until the Annual Meeting in 2017;

ii. To ratify the selection of Arnett Foster Toothman, PLLC, as the Company’s independent registered public accounting firm for the year ending December 31, 2014;

iii. To approve the Summit Financial Group, Inc. 2014 Long-Term Incentive Plan, and

iv. To transact such other business as may properly come before the Meeting.

(b) The total number of shares of the Company’s common stock issued, outstanding and entitled to vote at the Annual Meeting was 7,457,222 shares of which 5,394,881 shares representing 72.3% were present at the meeting either in person or by proxy. The holders of common stock of the Company voted on three proposals. No other business was brought before the meeting.

The results of the voting on the three proposals were as follows:

(i) Proposal 1 – To elect five (5) directors to serve until the Annual Meeting in 2017.
