(1) This amended Form 4 is being filed to correct the number of shares acquired by the reporting person on January 27, 2010. The amount of securities reported in Column 4 of the original Form 4 as being acquired in this transaction was incorrect, but the total amount of securities reported in Column 5 of the original Form 4 as being beneficially owned by the reporting person was correct. Pursuant to Instruction 9(b) to Form 4, only the lines of the original Form 4 requiring correction or amendment are being restated on this amended Form 4.

(2) These shares are subject to certain restrictions, and vest when such restrictions lapse. Partial vesting of these shares occurs on February 10 of each of the three years beginning in 2011, based on certain performance standards. If it is not possible to determine whether the performance standards have been met on any particular vesting date, the vesting date will be extended until such determination can be made. Any of these shares not vested as of February 10, 2013 will be forfeited.

(3) These shares are subject to certain restrictions, and vest when such restrictions lapse. One-third of these shares vest on February 10 of each of the three years beginning in 2011, subject to certain performance standards. If it is not possible to determine whether the performance standards have been met on any particular vesting date, the vesting date will be extended until such determination can be made. Any of these shares not vested as of February 10, 2013, may vest over the next two years if the performance standards are then satisfied. Any of these shares not vested as of February 10, 2015, will be forfeited.
