- (2) These restricted shares were forfeited by the reporting person pursuant to the terms and conditions under which they were issued to the reporting person. No price was paid or received by the reporting person in connection with this forfeiture.

- (4) These Share Units correspond to shares of Common Stock of the Issuer. The Share Units are settled in cash if and when they vest.
