- (1) The Form 4 filed on April 2, 2015, incorrectly reported that Mr. Obus received 9,634 shares of restricted stock as part of his annual director's equity award. This amended Form 4 is being filed to show that Mr. Obus's annual award consisted of 4,817 shares of restricted stock and 15,528 options.
- (2) Of the 66,018 shares reported as being held by the reporting person, 14,638 shares are held directly by Mr. Obus and 51,380 shares are held indirectly by Mr. Obus through Wynnefield Partners Small Cap Value, L.P., Wynnefield Partners Small Cap Value, L.P. I, and Wynnefield Small Cap Value Offshore Fund, Ltd. (collectively, the "Wynnefield Entities"). Mr. Obus disclaims beneficial ownership in such shares except to the extent of his beneficial interest in the Wynnefield Entities.
