TELEFÓNICA, S.A. (TELEFÓNICA or the Company), in accordance with the provisions of Article 228 of the Securities Market Act, hereby issues the following

SIGNIFICANT EVENT

Today, TELEFÓNICA, S.A., through its wholly-owned subsidiary TELEFÓNICA EMISIONES, S.A.U., under its Guaranteed Euro Programme for the Issuance of Debt Instruments (EMTN Programme) filed with the Financial Conduct Authority (FCA) in London on June 5, 2015, has launched an issuance of Notes guaranteed by TELEFÓNICA, S.A. in the Euro market in an aggregate principal amount of 2,750 million euros.

This issue was split into two tranches. The first tranche, amounting 1,400 million euros, due on April 13, 2022, pays an annual coupon of 0.75%, issued at par. The second tranche, amounting 1,350 million euros, due on April 13, 2026, pays an annual coupon of 1.46%, issued at par.

The settlement and closing date is scheduled for execution on April 13, 2016.
