On July 17, 2003, Premier Bancorp, Inc. announced that it will redeem all outstanding shares of its Series "A" 9.25% Preferred Stock in connection with its pending merger with Fulton Financial Corporation which is expected to close in the third quarter of 2003. The redemption price is \$25.50 per share. A final dividend of \$0.578125 per share will be paid on July 31, 2003 to shareholders of record on July 16, 2003.
