Item 2.02. Results of Operations and Financial Condition.

On July 25, 2006, Banta Corporation (the Company) issued a press release (the Press Release) announcing the Companys second quarter financial results for the period ended July 1, 2006. A copy of the Press Release is being furnished as Exhibit 99.1 to this Current Report.

Use of Non-GAAP Measures

The Company reports its financial results of operations in accordance with generally accepted accounting principles (GAAP). The Company has also provided non-GAAP financial information to complement its consolidated financial statements presented in accordance with GAAP. The non-GAAP financial measures included in the Press Release include the Company s earnings and diluted earnings per share from continuing operations for the three- and six-month periods ended July 1, 2006, excluding the reversal of a tax contingency reserve related to incentives granted by the Singapore tax authority. Management believes it is useful for investors to understand how its core operations performed without the effects of the reversal of the tax reserve.

In the Company s judgment, excluding the reversal of the tax reserve from the Company s financial results allows investors to trend, analyze and benchmark in a meaningful manner the performance of the Company s core operations. In addition, the Company believes that providing earnings and diluted earnings per share from continuing operations excluding the reversal of the tax reserve provides another useful comparison of the Company s operational performance in 2006 to the comparable periods in 2005 and expected performance in 2006. The Company has provided within the Press Release a reconciliation of the non-GAAP financial measures to the most directly comparable GAAP financial measures.

The non-GAAP financial measures included in the Press Release are intended to supplement the reader s overall understanding of the Company s current financial performance and its prospects for the future. However, the non-GAAP financial measures are not intended to supersede or replace the Company s GAAP results or expectations.
