The governance, investment strategy and decision-making process with respect to investments held by the Bain Entities is directed by BCI's Global Private Equity Board ("GPEB"). Joshua Bekenstein is a Managing Director of BCI and a member of GPEB. By virtue of the relationships described in these footnotes, Mr. Bekenstein may be deemed to share voting and dispositive power with respect to all of the shares of Common Stock held by the Bain Entities. Mr. Bekenstein disclaims beneficial ownership of such securities except to the extent of his pecuniary interest therein.
- (3) On July 9, 2015, the Bain Entities distributed 365,686 shares of Common Stock to one or more members or partners of the Bain Entities including 145,404 shares to Mr. Bekenstein in connection with certain charitable gifts made by each member or partner on July 9, 2015.
