- (a) (b) As of October 7, 2002, Mr. Davis may be deemed to beneficially own 412,081 shares or .89% of the Issuer's shares issued and outstanding as follows: (i) 50,156 shares owned directly by Mr. Davis, (ii) 303,325 shares owned directly by Blair Investment, and (iii) 58,600 shares owned directly by Rosalind Davidowitz (1).

As of October 7, 2002, Blair Investment may be deemed to beneficially own 303,325 shares or .67% of the Issuer's shares issued and outstanding as indicated in (ii) above.

- (c) Mr. Davis has sole power to vote or to direct the vote, to dispose or to direct the disposition of those shares owned by Blair Investment. Rosalind Davidowitz has sole voting and dispositive power over those shares owned directly by her.
