DTE Energy Company ("DTE Energy") will meet with investors September 28-29, 2015. A copy of the slide presentation from the meetings and the business update presentation is furnished as Exhibit 99.1 to this report and will be available on DTE Energy's website, www.dteenergy.com on September 28, 2015. The presentations from the meetings on September 28, 2015 will be webcast live on DTE Energy's website, www.dteenergy.com, from 11:30 a.m. to 3 p.m. EDT. In the meetings and the presentation, DTE Energy increased its 2015 operating earnings per share guidance to \$4.65-\$4.91 per share from \$4.54-\$4.90 per share. DTE Energy also announced its early outlook for 2016 operating earnings per share guidance of \$4.80-\$5.05 per share.

In its slide presentation and this filing, DTE Energy discusses 2015 and 2016 operating earnings guidance. It is likely that certain items that impact the company's 2015 and 2016 reported results will be excluded from operating results. Reconciliations to the comparable 2015 and 2016 reported earnings guidance are not provided because it is not possible to provide a reliable forecast of specific line items. These items may fluctuate significantly from period to period and may have a significant impact on reported earnings.
