DTE Energy Company ("DTE Energy") will meet with investors May 7, 2018. In the meetings, DTE Energy reaffirms its 2018 operating earnings per share guidance of \$5.57-\$5.99 per share.

In its slide presentation and this filing, DTE Energy discusses 2018 operating earnings guidance. Reconciliations to the comparable 2018 reported earnings guidance are not provided because it is not possible to provide a reliable forecast of specific line items (i.e. future non-recurring items, certain mark-to-market adjustments and discontinued operations). These items may fluctuate significantly from period to period and may have a significant impact on reported earnings.
