CGII does not have investment power or voting power over any of the securities reported herein. However, by virtue of Rule 13d-3 under the Act, CGII may be deemed to "benefically own" 4,317,340 shares or 13.4% of the 32,101,890 shares of Common Stock believed to be outstanding.

Capital Guardian Trust Company, a bank as defined in Section 3(a)(6) of the Act is deemed to be the beneficial owner of 3,922,940 shares or 12.2% of the 32,101,890 shares of Common Stock believed to be outstanding as a result of its serving as the investment manager of various institutional accounts.

Shares reported by Capital Group International, Inc. include 4,890 shares resulting from the assumed conversion of \$242,000 principal amount of the 5.25% Convertible Note, due 11/15/2006.
