General

The securities are designed for investors who seek a return at maturity of at least 260.00% (to be determined on the Trade Date) of any increase in the level of the EURO STOXX 50[®] Index (the "**Underlying**"), up to the Maximum Return of at least 65.00% (to be determined on the Trade Date). If the Final Level is less than the Initial Level but greater than or equal to the Trigger Level (equal to 75.00% of the Initial Level), investors will receive a cash payment at maturity equal to the Face Amount per \$1,000 Face Amount of securities. However, if the Final Level is less than the Trigger Level, for each \$1,000 Face Amount of securities, investors will lose 1.00% of the Face Amount for every 1.00% by which the Final Level is less than the Initial Level.
